壹、 背景說明 Preface

我國與歐盟自 2015 年「第 26 屆臺歐盟年度諮商非經貿議題會議」開啓性別平權交流合作事宜，在雙方認同政策理念相近情形下，啟動「臺歐盟性別平權合作暨訓練架構計畫(GECTF, 2019-2023)」，以臺灣作為平臺，連結歐盟作為學習夥伴，針對性別主流化推動機制、LGBTI 權利保障、公私部門決策參與之性別平等、破除性別刻板印象、改善教育與職業性別隔離等性別平等議題、政策與經驗進行廣泛的跨國交流，共同追求平等與人權價值。

EU and Taiwan launched the gender equality cooperation in 2015 during the 26th EU-Taiwan Annual Consultation on Non-trade Issues. Sharing a common goal of promoting gender equality, we launched the EU-Taiwan Gender Equality Cooperation and Training Framework (GECTF) in 2019, which runs until 2023. As a learning partner, we use Taiwan as a platform to promote gender mainstreaming mechanisms, ensure LGBTI rights, increase gender balance in decision-making in public and private sector, eliminate gender stereotypes, and reduce gender segregation in education and careers. Through extensive cross-border gender equality issues, policies, and experiences exchange, we are jointly pursuing values of gender equality and human rights.

GECTF 自 2019 年啓動以來，臺歐盟雙方一同見證我國同性婚姻法「司法院釋字第七四八號解釋施行法」實施，並陸續合作辦理多場工作坊及研討會：於 2019 年 6 月辦理「臺歐盟性別平權與人權系列培訓課程－性別主流化工作坊」，亞太地區 9 個國家政府官員共同討論性別主流化在各國的推動，各國發展出充滿在地智慧及活力的創新方法，相關交流及借鏡學習；同年 10 月辦理「LGBTI 人權推動研討會－婚姻平權與同志人權保障」，計有來自歐亞 31 個國家 280 名代表共襄盛舉，針對性別平權政策推動經驗進行交流，共同推升亞洲地區 LGBTI 人權；進一步於 2022 年 10 月辦理「LGBTI 人權推動研討會－雙性人、跨性別者及同志權益保障」，來自亞洲、歐洲及美國等 21 個國家代表實體及線上參與，相互激勵去創造一個性別平等與多元的世界。

Since 2019, GECTF has witnessed several milestones in the promotion of gender equality and LGBTI rights, such as the Act for the Implementation of Judicial Yuan Interpretation No. 748 regarding same-sex marriage in Taiwan. Both sides have co-hosted numerous seminars and workshop, including the "EU-Taiwan Gender Equality and Human Rights Training Course: Gender Mainstreaming Workshop" in June 2019, where government officials from 9 Asia-Pacific countries discussed the promotion of gender mainstreaming tools and shared innovative approaches and local expertise. Additionally, the "EU-Taiwan LGBTI Human Rights Conference: Marriage Equality & Protection of LGBTI Rights" was held in October 2019, where 280 representatives from 31 European and Asian countries gathered to exchange experiences on promoting gender equality policies and LGBTI human rights in the Asian region. Furthermore, the "EU-Taiwan LGBTI Human Rights Conference:

Intersex, Transgender & Protection of Lesbian and Gay Rights" was held in October 2022, attracted participants from 21 countries in Asia, Europe, and the US, both in person and online, to inspire each other to create a world of gender equality and diversity.

檢視及盤點亞太區域近年的發展，我們看到 2022 年 6 月泰國內閣通過「民事伴侶關係法案草案」；8 月新加坡宣布廢除禁止同性性行為的法律條文；11 月日本啟動東京都伴侶關係宣誓制度，可見亞洲 LGBTI 權益已有具體進展，許多國家也不懈倡議和努力。回首亞太地區各個國家持續推動性別平等的亮眼成果，以及所面臨的各種挑戰，我們更需要相互彼此交流及攜手合作，邁向性別多元、尊重及包容的願景。

Taking stock of recent developments in the Asia-Pacific region, we have found that the Thai cabinet passed the "Civil Partner Bill" in June 2022, followed by Singapore's announcement of the repeal of laws prohibiting same-sex acts in August and Japan's launch of the Tokyo Partnership Oath System in November. It is evident that the rights of LGBTI in Asia have made concrete progress, and many countries are working tirelessly to advocate for and advance them. Despite these fruitful results, we still face challenges in achieving gender equality in the Asia-Pacific region. To move towards our vision of a diverse, respectful, and gender-inclusive society, we need to communicate and collaborate with each other more effectively.

今（2023）年是 GECTF 最後一年，臺歐盟將於 7 月辦理本次論壇作為 GECTF 階段性總結。因應後疫情及數位時代發展的持續考驗及挑戰，各國盤點及交流疫情間面對的性別平等議題，以及提出後疫情時代推動性別平等之策略及願景。我們深切期盼擴大臺歐

盟性平交流效應，積極促進性別平等與婦女賦權，帶動亞太區域性別平等與人權進展。

2023 is the last year of GECTF, the forum will serve as a stage-wise conclusion of GECTF, where countries will take stock and exchange gender equality issues in response to the continued challenges of the pandemic and digital era. They will propose strategies and visions for promoting gender equality in the post-pandemic era. We deeply hope to expand the effects of GECTF, which actively promote gender equality and women's empowerment, and driving the progress of gender equality and human rights in the Asia-Pacific region.
